### Safe Route to School Safety Study

The pilot safety review project by FDOT and in coordination with Space Coast TPO was only funded for 4 schools to be studied from the City of Palm Bay and 4 from the City of Melbourne. The four school sites submitted from Palm Bay were the following:

- 1. Lockmar Elementary School,
- 2. Riviera Elementary School,
- 3. Turner Elementary School, and
- 4. Odyssey Charter School

The next few steps of the project are as follows:

- 1. Scope to be reviewed by FHWA and FDOT
- 2. Scope approval by SCTPO Governing Board in April
- 3. Notice to Proceed issued
- 4. Kick-Off meeting late spring/early summer
- 5. Summer 2019 will be spent preparing for field visits to each of the schools
- 6. Fall 2019 field visits will be conducted

The City's Engineering Division will be the lead to coordinate his project with the TPO and FDOT and the final report will be present to the IAOB for review and discussion.
