Mayor Capote understood that social media was a main venue to get information out to the residents, but he wanted to ensure that all avenues were utilized, including radio. He said that many residents did not use or have access to the internet. Mrs. Morrell said staff would do its best to get information out in other ways.

1. Peter Filiberto, resident, asked if quarantined employees could be paid from the contingency fund instead of having to use their personal time. Mrs. Morrell advised that all employees were being paid at this time and were not using any personal leave. Mr. Filiberto requested an update on the Southern Interchange. Mrs. Morrell said that staff had a brief meeting with Brevard County this week, with a follow-up conversation to occur next Wednesday. Brevard County would be providing its comments at that time.

Mr. Anderson said he had spoken to Commissioner Isnardi and the County Manager about the Interlocal Agreement (ILA) and everyone seemed to be in agreement that the next ILA draft should be fair to both entities.

SUMMARY:

The City of Palm Bay was awarded Safe Routes to School (SRTS) federal funds from the Florida Department of Transportation Local Agency Program (FDOT LAP) for the design of sidewalks and surrounding crosswalks for five Elementary Schools - Port Malabar Elementary, Christa McAuliffe Elementary, Columbia Elementary, Discovery Elementary, and Jupiter Elementary. Council awarded the competitively solicited engineering contract to Infrastructure Engineers, Inc. (now called Consor Engineers, LLC) on June 7, 2018. The City through resolution entered into LAP agreements with FDOT for those designs on April 5, 2018 resolution 2018-10-14. LAP award amount covered 100% of the engineering award amount. Design is now complete.

The City of Palm Bay was then awarded Safe Routes to School FDOT LAP federal funds for the construction of the same five sidewalks and surrounding crosswalks for the following five Elementary Schools in the amounts listed below:

•	Columbia Elementary	\$338,689
•	Discovery Elementary	\$412,497
•	Jupiter Elementary	\$917,369

Funds for construction are programmed by the State for fiscal year 2020. The LAP Agreements for construction were approved by City Council by resolution 2019-49 to 2019-53 in order to accept the funds and solicit for construction bids. The City Procurement Department, with the assistance of the Public Works Department, solicited bids for the construction of the projects following signature of the LAP agreement by both the City and FDOT and Notice to Proceed from FDOT.

Two bids were received for the project. The Procurement Department staff reviewed the bids for responsiveness. Public Works Department evaluated the bids for responsibility and ability to perform the scope of services. The Department found the lowest responsive bid to be acceptable. FDOT concurred on the City's recommendation on April 1, 2020.

The City's projected budget for this project was \$2,490,058. Public Works staff has reviewed the low bidder's Summary of Pay Items, proposed Subcontractors, Equipment List and References and is satisfied with the evidence provided by the contractor. Staff recommends Gregory Construction, Titusville, Florida for award of IFB 19-0-2020/SB- Safe Routes to School Sidewalk Construction.

Local Preference was not applied to the two vendors as it is prohibited when utilizing Federal funds.

SUMMARY:

Public Works is responsible for the maintenance of over 105 miles of canals and ditches in the City of Palm Bay. Over the past 30 years, some ditches have fallen outside the City's scope to maintain. Many of these ditches were built with only one access road for maintenance and others were built with no access road for maintenance, subsequently leaving the ditches unmaintainable. Although some overgrown ditches function with the ability to carry the capacity of water they were designed for, others have failed due to erosion, overgrown vegetation on the banks and others have become a liability during hurricanes to homeowners' property; growing past the City right of way (ROW). The goal of this project is to remove the overgrown vegetation on seven (7) canals, located in the Northeast and Southeast of Palm Bay. At the end of the project a total of 14,020 linear foot of canal banks will be maintainable for in-house forces.

The City solicited for a base bid of four (4) ditches deemed to be most critical, with an alternate of three (3) additional ditches if funding allowed. Six (6) bids were received in response to the City's solicitation. Procurement staff reviewed the bids for responsiveness, and two (2) bids were deemed non-responsive for not meeting the licensing requirements. Public Works staff evaluated the bids for responsibility and ability to perform the scope of services. The department found the lowest responsive bid to be acceptable. The department requests award of both the base bid and the alternates, for a total award of seven (7) ditches.

Staff recommends Universal Contracting & Construction, Inc. as the contractor for Ditch

SUMMARY:

Wade Trim has submitted Task Order 20-05, South Regional Water Reclamation Facility (SRWRF) Engineering Services During Construction for approval. The scope of work will consist of Engineer of Record services and on-site project management from the pre-construction process through project closeout.

On April 17, 2008, City Council awarded Wade Trim Task Order 07-06, South Regional Water Reclamation Facility Design, Permitting, Competitive Solicitation Process Assistance and Construction Services, through competitive Request for Qualifications process (RFQ #68-0-2007). This project was subsequently put on hold when development in the City declined. Over the past several years, the City has been experiencing growth and will require an increase in wastewater treatment disposal capacity to meet demands. In 2015 the process was re-started for the construction of a SRWRF using the original design from RFQ #68-0-2007. It was determined that a design assessment, update, and permitting would be required and these were completed under Wade Trim Task Orders 15-06, 16-08, and 0018-2017 (approved by Council September 17, 2015, August 4, 2016, and November 2, 2017 respectively). This is permitted under Florida Statute 287.055(10), Reuse of Existing Plans, which states: "there shall be no public notice requirement or utilization of the selection process as provided in this section for projects in which the agency is able to reuse existing plans from a prior project of the agency."
