REPORTS:

1. Parks and Recreation Reports – Fred Poppe, Director of Parks and Recreation

Mr. Poppe made the following reports:

• The quote for the pool slide at the Palm Bay Aquatic Center came in \$60,000 over budget.

- Basketball courts at West Pine should be completed by the end of May 2021.
- The sewer project at Fred Poppe Regional Park (FPRP) was ahead of schedule and should be completed by May 2021.
- Requests for Proposals for playground equipment were due by the end of May 2021 and four (4) of the playground equipment had been removed.

Mr. Poppe said he would be attending the Citizens Budget Advisory Board meeting on April 14, 2021. He would discuss future plans for a south regional park due to the increased housing near the new interchange.

Mr. Poppe discussed the possibility of a Palm Bay Fairgrounds and announced the renaming and dedication ceremony scheduled for the baseball/softball complex at FPRP April 15, 2021, at 5:30 PM.

Mr. Poppe discussed working with the Brevard Caribbean American Sports and Cultural Association (BCASCA) regarding the Multi-Cultural Event scheduled for September 2021. The Palm Bay Chamber was also involved.

The Board discussed having a group tour of all Parks and Recreation facilities in the near future.

NEW BUSINESS:

1. Consideration of Renaming of Castaway Point Park

Mrs. Shoemaker addressed the Board regarding the renaming of Castaway Point Park to the Kayla Marie Shoemaker Memorial Park. Mr. Flowers read a letter on behalf of Mrs. Shoemaker and distributed photographs of Kayla.

Discussion ensued and several alternatives were given should the Board and/or City Council deny the request.

Motion by Mr. Aubin, seconded by Mr. Capote, to deny the request. The motion carried unanimously.
