- Free admission to the public. Live band, entertainment, kids' zone, food trucks, vendors, and FIREWORKS!

Information and Requirements: (Please read carefully)

- Vendor fee is \$175.
 - o Fee is payable by cash, money order or credit card
- Vendor Registration deadline is Monday, June 26, 2024
- Registration is first come, first served
- Applications must be pre-approved for this event. Palm Bay Recreation reserves the right to refuse any vendor application.
- Vendor must read and sign the attached waiver. Please fill out Vendor Registration Form completely.
- Vendors must provide a copy of their current Florida business license.
- Vendors must be current with yearly PBFD inspection and comply with all state, county and city codes.
- Vendors will also be required to provide the city with a certificate of liability insurance with \$1,000,000 of personal/adv injury and \$2,000,000 general aggregate. Eastern Florida State College must be listed on the policy in the bottom left corner as a certificate holder with their address:

- o Additional description must read: "City of Palm Bay Recreation / Eastern Florida State College are added as additional insured with respect to General Liability via form."
- All fees for the event are non-refundable, unless event is cancelled by the City of Palm Bay.
- Vendors cannot request a space location. Locations will be determined by the Recreation staff.
- Vendor set-up time is between 2 PM and 4 PM.
- All food vendors MUST be set up in their assigned location, with vehicles moved to the proper parking location, no later than 4:45 PM. No refunds will be issued if you arrive late. Support vehicles must be parked in the parking area only.
- Vendors must stay open until 9 PM.
- Vendors can begin packing up after 9 PM, but for safety purposes, no vendor will be permitted to drive their vehicle on the fairgrounds until the fireworks have concluded and confirmation has been given by Recreation personnel that it is safe to drive in the area. However, vendors are free to walk their equipment to their vehicle during the fireworks.
- The vendor is responsible for leaving the vendor area in the condition that it was originally received, i.e. remove all debris such as boxes and trash.
