1. Election of Chairperson and Vice-Chairperson

2. Funding Recommendations for the Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) for PY 2025-2026

Public Services applications: Ms. Carter provided an overview and summary of funding recommendations by staff. She explained that staff used \$776,641 as an estimated funding amount for PY 2024-2025. The final funding amount would be provided to the City in May 2025 and the numbers would be adjusted accordingly. After staff reviewed and analyzed the applications, the following agencies were recommended for funding to the limit of the City's maximum cap of \$116,496 with the U.S. Department of Housing and Urban Development (HUD):

•	Catholic Charities	\$ 35,000
•	Club Esteem, Inc.	\$ 15,000

3. CDBG Substantial Amendment for PY 2022-2023, 2023-2024, 2024-2025 Annual Action Plans

Ms. Carter explained the proposed changes constituted substantial amendment #2 which was publicly noticed in Florida Today Newspaper on February 19, 2025. The City was in the public comment period from February 19, 2025, through March 30,2025. The City proposed to reallocate leftover funds from completed projects, cancel a project and allocate funds to a new project that was ready to start. Details explaining each amended item were listed as an attachment to the agenda packet. HUD would also have to approve the amendment.

Individuals made general comments.

Mr. Olszewski agreed to the project delivery cost of the Inspector and recognized the justification.

Dr. Livingston and Mr. Olszewski stated the people living in census tract 71339 were still in need of sidewalks.

Chairperson Thibert stated the in-house Inspector was a great need for the Housing Division.

Dr. Livingston said the perception was that the income of the area had changed, but the need was there.

Motion by Dr. Livingston, seconded by Mr. Olszewski to approve the Substantial Amendments # 2 for PY 2022-2023, 2023-2024, 2024-2025 CDBG Action Plans and submit the amendments to City Council and HUD for approval. Motion passed unanimously.

OTHER BOARD BUSINESS:

1. Informational: Staff Report

Ms. Carter wanted to point out a special note to the South Brevard Women's Center (SBWC) rehabilitation of Tranquility Cove Transitional Housing project. The agency advertised for bids on January 14, 2025, and the bids were opened on February 4, 2025; five (5) bids were submitted. The lowest bidder was Harland Property Development. The bid amount did not include the contract fees charged by the architect, nor enough contingency. The rehabilitation project would have significant complications. Staff would be submitting this project to City Council to increase the contingency amount prior to SBWC executing a contract with the contractor. This project would be funded through the SHIP program.
